TREE REMOVAL WARNING AT UNIVERSTIY SQUARE

Owners at University Square are responsible for the maintenance of front yard trees. This includes the trees between the street and sidewalk in front of their homes. These trees must be pruned to maintain their shape and prevent them from growing into the buildings. Sometimes roots from these trees also cause problems with sidewalks, foundations and other landscaping making the trees candidates for removal.

Unless you are going to replace a tree with another of the same species, however, you cannot remove a tree in your front yard without first obtaining Association approval. There is a specific form for requesting Architectural Approval to make changes to the landscaping in your front yard. The 2008 Annual Meeting of the members of the University Square Homeowner's Association was held at 7:00 PM on Thursday, June 11, 2008 in the Council Chambers at 2415 University Ave.

ESTABLISHMENT OF A QUORUM

A Quorum was established by the presence of 76 owners either in person or by proxy.

APPROVAL OF THE MINUTES OF THE 2008 ANNUAL MEETING

In advance of the meeting, copies of the minutes of the 2008 Annual Meeting were provided to the Homeowners. Mr. Ferrari asked if there were any changes or corrections to be made to those minutes. There being no response, a motion was made and duly seconded that the minutes be approved. A later counting of the ballots indicated that the motion carried.

ELECTION REGARDING EXCESS OPERATING INCOME

Mr. Ferrari then explained the possible tax benefits of making an election with regard to year-end excess operating income, if any. A motion was made and duly seconded that the following resolution be adopted:

Introduction


