Annual Budget Report

The most important document enclosed is your 2016 Operating Budget. The Board of Directors and Massingham & Associates are tasked with ensuring a secure financial future of the Association's assets and your home value. The budget for 2016 was approved by the Board of Directors with the intent of providing this security as well as maintaining and enhancing the community's facilities, appearance, and resident's quality of life.

After review of previous years' expenses and anticipated future expenses, the Board of Directors has approved an Annual Assessment for 2016 of: \$144.00. The 2016 Annual Assessment becomes effective January 1, 2016. Statements will be mailed to you prior to this date.

Please be advised that there is not a current Reserve Study on file at this time. The reserve fund with a current balance of \$12,269.91 and the funding plan are established to provide for the maintenance and replacement of the Association's capital assets and major components. The Board of Directors does not anticipate a Special Assessment to provide adequate reserve funds to repair, replace, or restore any major association component.

Annual Policy Statement
